Spring work weekend will be held on Saturday 5/10/2014. Please bring tools/gear for road work, cabin repairs, firewood splitting, brushing, & painting. Tractors/loaders and dump trailers, or the like, would be appreciated for road work. Breakfast, lunch, and dinner will be served at the main lodge on Sat (and breakfast on Sun), but please bring your own drinks. I will notify all via e-mail if road or weather conditions cause us to postpone spring work weekend.

We may **draw for the rifle** if all tickets have been sold, so please return all stubs and to Al or Barry before 5/10/2014.

The frost has not come out of club roads yet; thus, all roads are closed to trucks and SUVs until notified by e-mail.

The new (2014) gate combination will take effect on Sunday May 11th. Please contact Barry if you paid your 2014 dues and do not get a 2014 card at spring work weekend, or in the mail before 5/16/14.

ALL MEMBERS AND GUESTS MUST SIGN THE LOGBOOK AT THE MAIN GATE. Any guest, who is on the lease and did not sign the logbook may be asked to vacate the property - and not be permitted to return. Any member who is on the lease and did not sign the logbook will also be asked to return to the gate and sign in.

The annual Robinwood picnic will be held on July 26, 2014. We will have a meal, an auction, and music starting about 2PM.

The 2014 annual membership dues are still \$700. Full dues or a partial payment (\$400) is owed by May 10, 2014. **Cabin taxes** have been increased to \$150 and are due by August 15, 2014. Costs for **propane tanks** are now \$100, but may change after our first delivery; Missed work weekends have increased to \$50 and guest fees remain at \$10 (for 1 or 24 hrs). All fees are due within 30 days from the date first incurred; a 10% per-month late fee will be owed to the club thereafter.

ATVs, boats, parking, fishing and hunting: Please note that all state regulations apply to you and your guests while at Robinwood Park. Members are responsible for all actions of their guests. Any violations of state regulations can threaten your safety and everyone's access (and use) of club roads and lakes. All ATVs and boats need to be registered, helmets are required for all ATV riders, ATVs have to be licensed and insured, PFDs have to be used while on the water, absolutely no parking is permitted on state land, and no motors are permitted in Lows Lake. To ensure a few people do not ruin the privileges we all enjoy, each member is asked to report any violators to the board. Penalties for violations can range from at least \$100 to the loss of your membership.

Firewood may only be cut from down, dead, or clump beech trees on the back 4100 acres or from marked trees up front. No firewood may be removed from, or brought onto, our lease. All firewood at the lodge is only for club (Moose and Squirrel) cabins-DO NOT TAKE THIS FIREWOOD.

2014 Club buttons will be available to paid members during spring work weekend, at the picnic, or at Al's and Barry's cabin. Buttons cannot be mailed.
