#### **2019 ANNUAL membership dues**

remain at \$800. Full or partial (\$500) payment is due by May 1<sup>st</sup>, 2019 (remaining dues \$300 by 8/1/19.) If

your plan is to pay at Spring work weekend (SWW), this is certainly acceptable. CABIN owner fee (taxes) remains at \$150 and are due by8/15/19. Annual camper/trailer site fee is \$100 and is due upon picking your site. If changing or receiving a site for the first time please remit a signed camper/trailer guidelines sheet to Bob B. Propane tanks are still \$100, missed work weekends continue at \$50 and guest fees are \$10 (for any part of a day). Winter guest fee is \$5 a day. All fees are due within 30 days from date incurred. A 10% late may be owed to the club thereafter. If anyone is in need of special circumstances for dues payment please contact Bob B. to work something out.

SWW will be held May 18 & 19. We ask participating members to bring tools for road work (chainsaws, brush snips, rakes). We will be cutting wood for club cabins depending on numbers present and whether we would like to continue our offer to members wanting some wood for \$50 a truck load (approx.), cut, split and delivered. First to let me know will be first, second & so forth. We will do our best to accommodate our member requests. Meals will be provided on Sat. breakfast (7 am), lunch (noon), dinner (6 am). Sunday breakfast is at (8 am).

Our **club bylaws** have been updated recently with some changes. We encourage all members to pick up a set as they will be made available at the dining lodge, or read them on the Robinwood webpage.

There will be a **NEW Brook Trout take sheet** to be completed if you take brook trout from Clear Pd. (Clear Pd. only). The sheet will be in the sign-in book and on a clip board in the dining lodge. Please fill out one or the other. Thank you for your cooperation.
