As most/all of you know the 2019/2020 dues year started May 1st (ends April 30, 2020). **Current dues are \$800**, missed work weekend if owed \$50. For any member paying in 2 payments, your 2nd payment is due by Aug. 1st. **CABIN** taxes (\$150) are due by Aug. 15th. Anyone wanting a **CAMPER/TENT** site (exclusive), this fee is \$100. **Guest** fees are \$10 (for any part of the day) during this time of the year. **PROPANE** tanks remain at \$100. ALL fees are due within 30 days from the date incurred. A 10% per month late fee is owed the club thereafter. REMINDERS: Please NO parking on the State land by the lakes and no motors are permitted in/on your boat/canoe on Lows Lake (beyond old jeep trail culverts).
