PICNIC TIME: That's right. We are holding our annual **summer picnic** on Aug. 14th. **Meal serving should start about Noon time**, with the auction to immediately follow. DUES & FEES: We have accepted 20 new members already this year, with our roster currently sitting at 131.

Current dues:

- * \$800 (for any member paying in 2 payments, your 2nd payment is due by Aug. 1st)
- * Missed work weekend fee \$50
- * Cabin tax (\$200) is due by Aug. 15th
- * Camper/tent site (exclusive) fee is \$100
- * Guest fees are \$10 (for any part of the day) during this time of the yr
- * Propane tanks remain at \$100

If someone needs special arrangements for any fee please let me know. **ALL fees are due within 30 days from date incurred.** A 10% per month late fee is owed the club thereafter. If you are

unsure or question if you owe anything, please contact me. **PLEASE** remember to **pick up your member card & button from the club mailbox at Bob B.'s camp.**

REMINDERS: PLEASE, NO PARKING on the State land by the lakes and no motors are permitted in or on your vessel on Low's lake (beyond the old Jeep trail culverts). Any vessel w/motor must be registered. ALL ATV's must be registered & insured (UTV's insured). Please wear your PFD's & helmets. Also please be aware of your speed on club roads.

There are still a few **member boats** that have not been identified. If you store your boat at the designated storage area please make sure your craft is marked with your identification.

All members & guests MUST sign the logbook at the main gate. Any member who is on the lease and did not sign in will be asked to return to the main gate and sign in.
